Coldharbour should be proud of this infrastructure developed over a number of years, it goes to make our village the unique place that it is. However, it should be acknowledged that the CSSC is run by volunteers with limited capacity without any paid management or administration support in place. Therefore, our expectations of the governance should reflect this; activities are organised by the community for the community. The CSSC does not have a policy or procedure in place to deal with conflict or complaints, nor does it have a safeguarding policy. The establishment of these policies are worthy of consideration. The relationship between CSSC and the CCC and the Bonfire Society could warrant further clarification, particularly in relation to any associated liabilities."

- 6. **Cricket Club Report**: John (JH) Had a good year in terms of players. Filled all of our fixtures which is extremely good. Picked up a new network of players who want to play up there. Didn't win many games and need to get better but did fill all fixtures. A Constitution for the cricket club is now in place and available on the web-site.
- 7. **Bonfire Society Report**: Alan Smith reported that he and Toby Ward are retiring as the organisers of the annual bonfire. This has mainly come about because having to go to an external company to supply and set off the fireworks no longer made it economically viable to continue. Also the National Trust have stated that the site by the cricket pitch can no longer be used and accelerants to light the bonfire can not be used on their land. All monies from the bonfire account will be transferred to the CSSC account for future use.

Alan and Toby must be thanked for all of their efforts over more than 20 years in organising this very popular event.

As to whether a replacement, probably smaller, event will be run after covid remains to be seen.

8. **Any Other Business**: Barry Hitchcock read out a statement regarding membership and governance issues. It was agreed by all present that this matter is now closed.
