- 4. **Actions from last meeting:** Most of the actions from 22<sup>nd</sup> February meeting were completed and discussed at AGM meeting 22<sup>nd</sup> March. Other outstanding action mentioned below.

Mark will take our information and turn it in to a professional format that will be submitted to Companies House. BJ and SMcL proposed and the committee agreed.

- 9. **Pavilion:** SMcL stated that Pavilion will be set up for solar energy by end of June and that BJ has helped enormously. Clarifications have come back and more paperwork submitted. £18,700 is the cost of the solar project. Still waiting to hear from Gatwick Trust in May. Finances for project not yet definite but many options available to cover costs. Hazel Watson will donate a further £1,000 towards security system at Pavilion.
